A “New Technology” Medallion Signature Guarantee may be obtained from any guarantor that is a member of the “New Technology” Medallion Signature Guarantee program. Eligible guarantors include commercial banks, trust companies, savings associations, and credit unions as well as registered broker-dealers. A notary public is not an acceptable guarantor.

If a “New Technology” Medallion Signature Guarantee is required, each shareholder’s signature must bear its own, separate signature guarantee stamp.
